## MINUTES FROM LAST YEAR'S MEETING January 29, 2017

Welcome! The Annual meeting was opened with a prayer

A round of applause for Fellowship, staff, stewardship committee, Mary Parmer

Motion to approve last year's minutes: MSC

**Featured Speaker:** Mary Parmer: Invite, welcome and connect. Video: Reasons people don't come to church. Connect is essential—hear people's stories. The relational core value is the center of this art.

Annual Report: Jered Weber-Johnson: We started with a theme: Love God, love neighbor. This is our guiding principle from the core of our scriptures. None of this work is new to St. John's. The alien among you must be treated as your own. Whenever you welcome the stranger, you welcome God. Speak against racial injustice, shelter the homeless, and take in refugees as we have done, despite all. We show up at Pride, Standing Rock, and bedsides of those who are sick. We have vastly expanded our ability to provide pastoral care. Deepen your own sense of connection, and grow into the community God has called us to be. Jered may go on a Sabbatical, a three-four month process of renewal.

**Stewardship: Lynn Hertz:** Things went well this year-so thank you! Thanks to those who faithfully pledge their time, talents and treasure.

**2016** Financials and 2017 Budget: Rick Rinkoff: ...In 2017 we're taking a major step towards ensuring the sustainability of our ministries, our programs, our staff, our finances and our endowment. Lynn Hertz stood up in front of you months ago and launched our Stewardship campaign; she told you that pledges didn't cover the cost of programs and ministries; that our endowment was forced to make up the difference and that pushed the draw rate to an unsustainable level of more than 5%. She said all of us were getting a dollar's worth of church for only \$0.93.

She asked you to close the gap – and you answered. She asked you to help reduce our reliance on the endowment – and you answered. Pledges for 2017 are at a record level, finally surpassing our previous high back in 2008. They are projected to cover 99% of all program and ministry costs. We're reducing our endowment draw rate to 4.5%. That's a reduction of \$30,000, even though the endowment went up in value last year. I've been involved with the church's finances for 17 years. When I got here, the draw rate was over 8%. It's now the lowest level I've seen. Thank you, thank you for all your generosity....Growth is important. Growth is good. It enables more Outreach, more Music, and from a Treasurer's perspective, it puts us on the road to financial sustainability. It allows us to realize the hopes and dreams that we articulated in our Strategic Plan. The plan is pretty blunt: "It would be desirable to reduce the draw rate to 3.5%-4.0% and have programming supported by pledges, offering, and other revenue sources." Thanks to you, we've taken a big step closer to delivering on that.

Lea Anne Schmidt chairs the New Member commission and has done a fabulous job on the front lines of enabling us to grow. The Vestry would like to allocate more of our resources towards growth, perhaps in the form of a new part-time staff position, but there wasn't enough room in the 2017 budget to accommodate that desire and still be able to report those 99% and 4.5% numbers. We're on the hunt right now for ways to fulfill the Vestry's wish. If you want to be part of the solution, please let Lea Anne or me know....

Last year we had a surplus of over \$24,000. \$3,667 of that will go into our restricted fund for future youth mission trips and the rest will be used to reduce our bank debt. That's the same formula we've used in recent years. Our surplus wasn't because we took in more revenue than expected. Revenue was within \$868 of plan, less than a 0.1% variance from budget. The \$24,000 came because we over estimated our expenses. The detailed financial statements show where: payroll (during the year there were changes in people and some positions were

unfilled); H2H (we didn't have all the families we originally expected); safe church (many people now take the program on line at no cost); utilities (I'm going with global warming on this one).

When you look at the 2017 budget, the numbers don't seem much different from 2016. Revenue and expenses were both up 6,000 on a total budget of just under 1 million. Not a lot of visible growth. But you'll see there's a new column on the budget handout – 2016 actual – and that's where the growth becomes visible because of the over-budgeting of expenses last year.

On the revenue side, the \$6,000 increase masks the fact that in round numbers, pledges are up \$35,000 and endowment income is down \$30,000. On the expense side, payroll looks unchanged when viewing the 2016 and 2017 budgets side by side; but it's actually going up \$15,000 when you consider what we actually spent last year. Ministry expenses look like they're dropping \$3,000 but our pledge to the diocese accounts for the decline and keep in mind that last year was artificially inflated by a one-time expenditure of \$6,000 on piano maintenance.

Outreach also looks unchanged on the budget but in fact spending is going up \$8,000. Parish programs show a drop of \$3,000; that's due to lower safe church and stewardship costs. Operating expenses – this is one category you want to see drop but it's going up \$9,000. Half of that increase is for repair & maintenance which is undertaking a big project this year – installing LED lights in the church. The other half is for a new line item called contingency. That's an unassigned expense right now and a logical source to fund part of our growth initiative.

... Pledges will cover 99% of program and ministry expenses this year. The formula actually includes all non-endowment income but in case you're wondering what it would take to cover 100%, the answer is another \$8,000. That \$8,000 could come from pledges, non-pledged income, Christmas / Easter offerings, rent from groups using our building, other income. It's a doable number; we might actually achieve that this year.

Reducing the draw on the Cornerstone Trust from 4.5% to 4% means a difference of \$27,000. To get there, either the value of the endowment would have to soar or income from all other sources would have to go up by \$27,000. The first scenario is beyond our control but the second one? Sounds like a Stewardship goal for 2018.

... sometime this year, we hope to be able to accept credit card payments on Sundays and – wait for it – an app on your smart phone for mobile pledges....

With that I'd be happy to take any questions. (no questions)

#### Church Growth and Opportunities: Jerry Woelfel: We are in an in-between state

It would be good to grow by about 50 members. We are in a 136 year old church, and the building is almost that old. Three members of the Vestry have volunteered to meet with all our committees to coordinate and compile a list of things that need to be done. In the coming months you may hear what we should do to stay warm, dry and sustainable. What else could we do to accelerate our growth? We may look at a Capital Campaign that would sustain both maintenance and enhancement. Everyone will have an opportunity to express their opinions and their wished for our growth. Thanks to all for your commitment to St. John's.



# STEWARDSHIP

St. John the Evangelist did something different with Annual Giving in 2017. We asked you to set the table for current AND future ministries with an audacious goal of 11% over the existing operating budget or a goal of \$640,000.

There were considerable challenges in addition to raising funds for the aspirational goal. Last year we witnessed the passing of a number of our long-time parishioners. Additionally, some parishioners experienced life transitions which impacted their giving. While St. John's needed to increase its giving by about \$70,000 to meet its aspirational goal, it needed to also raise an additional \$40,000 to address the loss of some significant pledges.

### Congratulations! We did it!

In 2017, St. John's gave generously and pledged \$575,506. In 2018, St. John's pledged and secured automatic deductions for a total \$640,616. Over 100% of our goal.

In addition to meeting its aspirational goal, the Stewardship Committee sought to raise funds from a broad base of support to ensure a sustainable funding structure. Of the 191 pledges received, 40 were new to St. John's. Additionally, of the 154 households that re-pledged this year, we saw a collective increase of 8% in their giving.

Finally, volunteering for the annual campaign significantly increased this year. Between formation planners, event planning, inviters/ callers, mission moment speakers, and communication support, we had more than 20 volunteers serving this year.

We thank each of you for helping to set the table for our ministries. In 2018, the Stewardship Committee will focus on continuing to strengthen our annual campaign infrastructure, bolstering our Planned Giving ministry, and creating year-round opportunities to thank each of you for all the ways you give of your time, talent, and treasure to support the mission and ministries of St. John the Evangelist.

#### **8 BANKCHEROKEE LOAN**

On August 9, 2011, the church authorized a loan with Bank Cherokee for roof repair and on August 1, 2014 borrowed additional funds for the Vault repair.

#### **Sally Sand** – Clerk (non-elected position)

Sally was baptized at St. John's in 1998 with her then 3-year-old son Jack ("I don't WANT water on my head..."). She is stepdaughter of lifelong parishioner Dorothy MacDonald. Sally has served on the Faith in Action committee and was a regular participant in the Huge Sale ministry, which cemented many of her most cherished relationships in the congregation. Sally is Division Philanthropy Director of the national nonprofit The Trust for Public Land, with the mission to create parks and protect land for people to ensure livable communities for generations to come. She lives in Saint Paul with her husband Charlie.

# **LITURGY**

Across the Episcopal Church, we place a high value and appreciation for our liturgical life together. The maxim, "*Lex orandi, lex credenda,*" or "the way of praying is the way of believing" is something we take to heart. Indeed, we might well translate the phrase more accurately to read "the way of prayer is the way of life." With such a vision, the liturgy—the place where we pray in community—takes on a significance that is hard to ignore.



Here at St. John's we tend to our liturgical life with a number of lay staff and volunteer ministries that, together with the clergy of our parish, set forth our "way of praying" in community. These ministries include:

- Lay readers, who give voice to the weekly scripture lessons and the prayers of the people
- Vergers, who lead our procession into worship and into the world and tend to the practical details on the periphery of the liturgy ("on the verge")
- Acolytes (often youth) who assist at the altar and carry torches to light the way into liturgy
- Ushers, whose duties before and during worship ensure a seamless service
- Greeters, who watch for those who are relatively new to our community and extend them a warm welcome
- Altar guild, who care for the altar, vestments, Eucharistic vessels, linens, and flowers

The liturgy includes so many practical tasks and the training, equipping, and communicating with all of these various parties, that we have also, in the past couple of years, established the Liturgy Team. Convened by the rector, the Liturgy Team plans for the liturgy, selecting the Rites and Eucharistic prayers that will accompany each liturgical season. They script special liturgies like Holy Week, review the past Sunday, prepare for atypical liturgies (Rite 13, commissioning new ministries, blessings and more), create prayers of the people, and edit bulletins (not the most glamorous task—but so important!). The leaders of each of each of the various liturgical ministries are invited to be a part of the Liturgy Team, along with additional volunteers, the director of music, the clergy, and other relevant staff as needed. The Liturgy Team meets as a whole on a monthly basis, and less formally on a weekly basis both electronically and in person.

The Ministry of Ushering for Special Events was active again this past year, the third year of providing ushers and greeters for events that involve certain invitations to the public (our community outside of St. John's) and for funerals. In 2017 they were present at Artaria rehearsals and concerts, organ concerts and music programs, special Holy Day observances, and more than a dozen funerals. The group shrunk this past year with the passing of Don Husband, a great loss to all of St. John's. We are in need of about 6 new faces in this ministry to provide the "on call" service the group offers our parishioners and the community around us.

Supported by the work of all of these ministries, together in 2017 we celebrated:

- 117 Eucharists, with an average Sunday attendance of 200 people
- 46 Daily Offices (including daily Morning Prayer during Advent, quarterly Noonday Prayer, Evensong, and weekly Sung Compline)
- 2 worship services on Easter Sunday, with 440 total in attendance
- 3 worship services on Christmas Eve, with 568 total in attendance

Thank you to everyone who gathered to serve and to worship in God's name and to proclaim with joy the good news of Jesus Christ.

# PASTORAL CARE

Confidential healing prayer, a comforting and listening presence, communion brought to those who cannot come to church: these are among the many ways we have tended to one another's spiritual, emotional and physical needs over the past year.

Lay pastoral caregivers are available to provide one-to-one care to parishioners in crisis or facing long-term challenges as well as to those who are homebound, ill, in hospital or in a nursing or rehab facility. The St. John's Circle of Care works closely with the clergy to provide care and support to parishioners through:





- Eucharist Visits and Visitors: 10 St. John's members bring communion to those homebound & others as requested. There are 15 homebound parishioners seen by lay pastoral care visitors, Eucharistic Visitors and clergy.
- **Prayer Lists:** A confidential prayer list is regularly distributed to the 19 members of the laity who have volunteered to pray for people on the chain. Public prayers, led by lay intercessors, are offered at 8am and 10am Sunday worship services.
- Lay Pastoral Care and Pastoral Visits: Four St. John's members participated in the Community of Hope International Lay Pastoral Care Training in partnership with Episcopal Homes: Lea Anne Schmidt, Diane Wallace-Reid, Gwen Odney, and Cynthia Bertheau. This brings the total of trained lay pastoral care givers to 9. Two lay pastoral ministers currently visit persons incarcerated and previously incarcerated. COHI and EMMA Circle of Care meetings continue monthly, facilitated by Susan Moss.



**The Prayer Shawl Ministry** is an open group of St. John's knitters who meet regularly to craft prayer shawls given to those facing life and health challenges. The ministry crafted 8 prayer shawls in 2017.

Clergy and lay pastoral caregivers also support parishioners through life changes and challenges. In 2017, we marked 3 births, 13 deaths, and 2 marriages in our parish, as well as ongoing visits by clergy throughout the year to parishioners who had been hospitalized.

The ministry of pastoral care is shared by every member of our parish. As Christians in community, we care for one another. We thank everyone who has offered their time and gifts.

# SPIRITUAL & COMMUNITY LIFE

At St. John's we're not just a "community"—we are a *spiritual* community. We believe that our life together has import and meaning for our individual and corporate spirituality and our life in faith. When we meet and socialize and share food, these acts are freighted with spiritual significance.

We have several ways to intentionally engage spiritual and community life. These include:









**Small Groups:** Currently 8 of these groups meet regularly in homes for fellowship, prayer, and study. A new group, "Thursday Morning Inquirers," meets at St. John's. New groups are formed every year as requested, in response to parishioners' spiritual and fellowship needs and their availability.

### Spiritual Life Groups:

• The **Men's Breakfast** met monthly on Saturday mornings for breakfast, prayer, and a chance to share and learn about the goings-on at St. John's.

• Older Wiser Laity (OWLs) met quarterly in 2017 for Noonday Prayer, followed by a speaker and a lunch served by the clergy and staff. Presentations included Sr. Julian, who spoke about her vocational and faith journey; and the Rev. Marcus Halley, Rector-Elect at St. Paul's Episcopal, Lake of the Isles, who presented "One Black Man Speaks To White Minnesotans About Race."

• The **Men's Gathering** met monthly on a Tuesday evening for beverages and snacks and a theological discussion.

• There are **other groups** forming for next year including parents with young children, and those with specific time and travel requests.


**Coffee Hour Hosts:** Those with the calling to offer food and fellowship took turns providing tasty treats after the 10am service each Sunday. Coordinator Paige Hagstrom also helped to create a supply of gluten-free treats with nutrition labels included, ensuring those with special dietary needs would be able to participate every week.

In short, there has been a lot of energy and time put into spiritual and community life at St. John's in 2017. There are new opportunities for more of it to emerge in 2018. We'd love to hear from parishioners who have ideas of other kinds of groups.

# FAITH FORMATION







Early last year we experimented with Feasting on the Word. It was worthwhile for those who came, but we redirected our efforts in the second half of the year to meet the same goals of the Feasting curriculum (i.e. a biblically based formation hour) and increase participation. To this end, we worked with CYF both to engage children during the 9am hour (to bring them into Godly Play better prepared to participate) and to free up their parents to come to 9am formation. We can report success on at least two levels: quantitatively, numbers are up for adult formation (with enthusiastic support of coverage for kids during that time and improved experience of children), and qualitatively, the fall focus on formation "stories" in both the Bible and our lives was successful--generally reviewed very enthusiastically by participants, and leaders reported higher than average levels of engagement by participants.

One of our great accomplishments this past year has been our theological reflection as a committee, as well as the refinement of vision for our aims and goals of formation, including the restructuring of the 9am hour to a more holistic hour of formation, as well as supporting a renewed vision for partnership in the formation of our children.

#### Summary and other notable events/accomplishments

- Changes to Sunday morning 9am hour produced excellent results
- Major increase in attendance in the fall for 9am, plus a very positive response to the programming content for fall

- Formation Commission advocated for more designated staff time toward Formation coordination and supervision/ administration—new full-time associate rector's title reflects this priority

# CHILDREN, YOUTH, & FAMILY



### Children's Ministry

(Children's Faith Connections and Godly Play)

- 28 children registered
- Began new program of faith formation this program year for children age 5-grade 6. All ages meet for the first hour for art, physical activity, and music. Children meet for Godly Play the second hour to hear and wonder about the stories of the People of God.
- CFC Chorus, led by Jessica Bandelin, has taken the place of Children's Choir. Children continue to sing on the first Sunday of the month September – May
- One new Godly Play storyteller has been added this year
- A new Christmas pageant format was introduced this year

# FAITH IN ACTION

Our mission statement states in part: "Through our Faith in Action Commission, St. John the Evangelist Episcopal Church advocates for hunger relief, safe housing, and accessible health services. ..., we embrace this mission through local and global partnerships, personal service, supportive prayer, and financial contributions."

There are many ways in which we lived out our mission during 2017.

• **Project Home** – Many thanks to everyone who volunteered with Project Home at St. John's during the month of February. Together, we provided over 2,000 hours of direct service to 8 different families experiencing homelessness. Our guests included 9 parents and 23 children ranging in age from a few months to 16 years old. We know the guests enjoyed the space and the hospitality. This could not have happened without the help of all of you! Special thanks to Don and Holly Weinkauf who coordinate this program.



- **First Nations Kitchen:** we prepared and served meals at First Nations Kitchen on 3 Sundays. This easy and fun ministry supports hunger relief primarily for indigenous people by providing fresh organic food. Approximately 40 different members of our faith community assisted in the food prep and service, including many of our youth.
- **Kayoro, Uganda:** Five parishioners along with our rector, Jered Weber-Johnson, visited the clinic sponsored by St John's. Six large suitcases were filled with necessary medical supplies including an abundance of over the counter medications donated by our faith community were delivered to the staff for use in the clinic. Jered offered a blessing and cut the ribbon on the new 6-bed maternity ward. As part of the trip, the volunteers made a presentation on reproductive health to about 60 youth. The young women present were taught to use and were given re-usable menstruation kits donated to us from "Days for Girls." Lea Anne Schmidt did a great job in planning and organizing this trip. In addition St John's donated to Give Us Wings, our Kayoro partner, over \$10,000 to assist in building onsite staff quarters.
- The Giving Tree: St. John's generously provided Christmas gifts to 18 families through our partnership with the YWCA. Fifty-one tags with gift ideas were made and hung on two trees for the members to take for shopping. When we started this program in 2010, we donated gifts to 12 families. We are now up to 18 families. Thank you to Sue Cadwell for organizing it.



**Farmers' Market and Fields to Families:** we continue to have 3 farmers from our sister parish, Holy Apostles, set up a market in the parking lot each Sunday May through October. The farmers are encouraged by the growth of the market and enjoy selling to the ST. JOHN'S community and our neighbors. We also buy produce from the farmers that we give to both Hallie Q Brown and First Nations Kitchen for their food shelves. Many thanks to Cammie and Rob Beattie for heading up this ministry.



- **Refugee Ministry:** Laura Smith and Dave Borton head up our Refugee Ministry. The team provided tremendous emotional support to our refugee family this year as they are assimilating into life here in MN.
- Hearts to Homes: we partnered with the YWCA in St Paul to mentor and provide financial assistance in the form of rent subsidies to 2 families as they transition from homelessness. This year Ian Dobson mentored a male head of household, a unique situation for us. Wuyah Koroma mentored our second family. Many thanks to both for their time and talents.
- **School Tools:** this annual gathering of school supplies is wonderfully supported by the ST. JOHN'S community. Thank you to Holly Weinkauf for leading up this effort.
- Food Shelf: we are looking for ways to continue our relationship with Hallie Q Brown in giving donated non -perishable foods.

# **MUSIC**

St. John's has a long tradition of excellent music that builds up the spiritual, liturgical and community life of the parish in Sunday services, as well as with Compline, Evensongs and special events that also enrich the musical life of the larger community. The music is often mentioned as one of the reasons a newcomer chose to join this church.





We are blessed with excellent material resources (an excellent organ, four fine pianos, and a set of handbells) and with strong support, both financial and general, from the parish and vestry. Our adult choir and handbell choir are stable; the children's choir has taken a new form as part of Children's Faith Connections; the youth choir is currently on hiatus. Several parish instrumentalists contribute music to services and events; and by providing a home for the Artaria Chamber Music School, we benefit from their musical gifts and support the youth of our area.

Musical events in 2017 included:

- Piano Celebration III, featuring guest pianist Osip Nikiforov and St. John's parish instrumentalists
- February Evensong
- Evensong with St. Mark's Cathedral Choir
- Evensong with St. Clement's Choir in celebration of the Organ Historical Society's national convention
- Youth choir cantata: "The Creation"
- Hosted choir of St. Martin's in the Field from London, England

During this past year, commission members have researched ways to humidify the organ blowers in order to keep the mechanical parts of the organ in better condition. We have also begun investigating ways to improve the very dry acoustics of the nave.

We are currently in a period of leadership transition. Our music program is continuing through this time of transition with the help of strong lay leadership and support from both parish volunteers and our lay clerks (paid section leaders), who have provided capable choral direction. We look forward to welcoming our interim director, Sonya Subbayya Sutton, organist and director, who will play for services, lead the adult and handbell choirs, and explore possibilities for youth musicians.

We are excited about the search, led by Fred Berndt, to find a new music director who will expand and strengthen the ministry of music at St. John's.

# MEMBERSHIP & MEMBER ENGAGEMENT

For our New Member Ministry, 2017 was a year of commitment, action and growth.



The year began with a highlight event when St. John's served as host of a conference led by Mary Foster Parmer, an internationally known Church Growth Consultant and creator of Invite, Welcome, Connect. In January, members of Episcopal churches from across the diocese gathered at St. John's to listen, learn and share ideas about the work of evangelism in the Episcopal Church. Following that workshop, at our 2017 Annual Meeting Rick Rinkoff announced that the vestry intended to create a part-time staff position to carry on and expand the work of the new member ministry committee.

In the spring of 2017, after conducting several interviews from amongst a strong field of candidates, Lea Anne Schmidt, who previously had been building our capacity through voluntary efforts, was selected as the Growth and Membership Engagement Coordinator. By creating the Coordinator position, we have been better able to meet the needs of our parish and our desire for future membership growth, by expanding the new member committee and dividing its participants into three teams, which align with the model of invitation, welcome, and connection. The committee is fortunate to be adding a new chair, Bette Ashcroft, to help lead and coordinate our teams.

With more allocated time for this vital ministry, the work continues. St. John's provides a warm welcome in numerous ways:



- As a welcome to the community, St. John's participated in the Ramsey Hill Home Tour, and hospitality was extended to all visitors by both new and long-standing members of the parish.
- The bread ministry remains vibrant: Over 50 loaves of bread were delivered to visitors throughout St. Paul and neighboring cities by our bread ministers.
- There's a warm welcome every Sunday: Our greeter ministry continues to expand with participation from new members, long-standing members, and our vestry.
- In Fall 2017, we initiated a Discover St. John's class, offered as needed, to provide visitors the opportunity to meet our rector, get a tour of the church, and ask questions about our parish and the Episcopal faith.

From our invitation and welcome, two robust Basics classes were held, and sixteen households were formally welcomed into the community of St. John's in 2017. Ten additional households are currently in the membership process. These new members bring many stories, talents, and gifts to our community, and in each person we get to see God in new ways. The majority of our newest members are actively engaged in the parish. 17 households have pledged financially, making a significant contribution towards St. John's meeting its 2018 pledge campaign goal. Several have joined small groups and are volunteering in ministries. More established members are reaching out to connect with our newest members in small and large ways from saying hello, to attending a new member class, to opening up their home to new members for dinner.

# BUILDING

The Building Committee is responsible for aesthetics and capital projects for St. John's.

### **Renovation:**

St. John's recent strategic plan identified some issues with our building that should be addressed in order to meet our goals for ministry and mission. Our church facilities are actually two very distinct buildings. The worship space was building in two parts — 1895 and 1903. The parish house was added in 1956 and has not been substantially changed since it was completed.

Last year the Abuilding Committee was asked by the Rector and Vestry to explore possibilities for renovation of the 1956 building. The renovation would include:

- A gathering space on the same level as the existing worship space
- A wider hallway from the worship space to the new gathering space
- All church offices consolidated into one location
- Inviting multi-purpose spaces that could be reconfigured for different uses

We have been working with BWBR Architects to develop some preliminary plans that will allow us to accomplish these goals and also:'

- Update mechanical systems and add air conditioning
- Install new bathrooms and kitchen facilities
- Relocate programming for children to current Undercroft area
- Create a youth space near the kitchen
- Upgrade Holly Street Entrance to be neighborhood-friendly and inviting

### Next Steps:

Before we go any further with this project, it is important to pause and allow time for everyone in the parish to learn more about the plan and to share their ideas and concerns. A major renovation requires the support of the majority of the congregation, and the next few months will be devoted to confirming that this is the right time for St. John's to take this next step in the implementation of our strategic plan.

### **Completed Projects:**

2017 was a banner year for visioning and creating. Completed projects this year include:

- Provided assisted-hearing devices for services in the church
- Architect chosen to work with us on the Vestry-endorsed vision for programming in the future
- The Stations of the Cross plaques designed and crafted by Sister Julian were installed on the south wall of the chapel
- New name tag storage designed and installed on the doors of the closets in the Narthex





# **PROPERTY**

The Property Committee is responsible for repair, maintenance, and upgrade work on the church building.

### 2017 proved to be a challenging year. The long list of completed projects includes:



- Masonry work was performed on the exterior to help prevent further deterioration of the stone and to stem water leaks.
- Three finials atop the bell tower were removed for repair as they were in danger of falling.
- The modern digital control of the HVAC system for the old building was installed following the failure of the previous antiquated control system.
- Signage for the HVAC Override Switches was installed in undercroft rooms, choir room, and by lectern.
- Many bulbs throughout the church were modernized to LEDs to reduce maintenance and electrical bills.
- Various pumps and motors in the boiler and chilled water systems were replaced as they failed.
- The parking lot drainage system was modified to prevent erosion and clogging.
- The Fire Panel is now monitored.
- The security system failed and was replaced with a modern system that has great expansion capability, monitoring capability, and also controls access from the main elevator to each floor.
- Bathroom light control: motion sensor lights and fan switches were installed in all bathrooms, to turn off lights & fans after a reasonable time period.
- Kitchen thermostat was replaced.
- Jesus' missing finger in the altar frieze was repaired.
- Handrails from the Narthex to the Undercroft were moved further from the wall, eliminating a hazard for hands.
- The recessed areas under the grates east of the old building were explored and the water drainage paths were cleared. Leaves were cleared from the gutters.
- The City of St. Paul pruned street trees outside our building at our request. There was an amazingly fast response, and the work was free.
- Our building manager, Scott Jungbauer, obtained his boiler license.

All in all, this was a busy year for the team and our building manager. We continue into 2018 with a long list of active projects as the older structures keep speaking to us with new leaks, mechanical noises, and failures.
